**Object : Change of Legal Name from CMI Defence S.A. to John Cockerill Defense S.A. as of March 1st, 2021.**

Dear Madam, Dear Sir,

Founded in 1817, the group proudly bore the name John Cockerill for over 150 years, before transforming itself into Cockerill Maintenance & Engineering, often hidden behind the acronym CMI. In May 2019, the group began a change of identity and is now called John Cockerill. In line with this evolution, the company name CMI Defence SA will change to correspond to its already well known trade name, John Cockerill Defense SA.

This change will take effect on **March 1<sup>st</sup>, 2021**.

This legal name change involves minor adjustments for invoicing. Practically, here is the procedure to follow for the **management of your invoices**:

- All services and deliveries performed until **28 February 2021** must :
  - Be invoiced to the company CMI Defence S.A. which has the VAT number BE 0563.837.739
  - Be invoiced on the date 28 February 2021 at the latest
  - Be sent to the following address:  
CMI Defence S.A., Service Comptabilités Fournisseurs, Avenue Greiner 1, B-4100 Seraing, Belgique
- All services and deliveries performed **as of 1 March 2021** must :
  - Be invoiced in the name of the company John Cockerill Defense S.A., having its registered office Rue Alfred Deponthière 44, B-4431 Loncin, Belgique and the VAT number BE 0563.837.739
  - Be invoiced on the date 1 March 2021 at the earliest
  - Be sent to the following address:  
John Cockerill Defense S.A., Service Comptabilités Fournisseurs, Avenue Greiner 1, B-4100 Seraing, Belgique

This change only affects the legal name but the legal entity behind that name remains as is. Also the delivery address and your contact persons remain unchanged.

Also, from an export control prospective, this legal name change involves minor adjustments for you. Practically:

- For those of you that have a TAA in place with us: This will require you to generate a minor amendment.

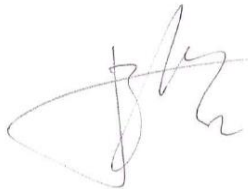
- For the management of your DSP's: you will receive shortly DDTC Web notice acknowledging our legal name change.
- For those of you that send controlled EAR materials under export licences: the **EAR 750.7(c)(2)** requires you to file a GC letter seeking authority for our name change.

We kindly request you to strictly comply with this procedure and to communicate it to the responsible members in your organization. This will prevent invoicing and payment issues.

In order to confirm that all modifications have been taken into account, we ask you to submit by mail or email the enclosed annex sheet, duly signed. Your contact person in the Supply Chain Department is available should you have any question regarding Purchase Order and invoice management.
